Cheeky Dog LLC General Information and Policies

The purpose of Cheeky Dog daycare is to provide a safe, fun and stimulating social environment for dogs. To ensure the safety and health of your pet and our other guests, we require all guests to comply with the following rules:

ACCEPTED DOGS: All dogs must be 16 weeks of age or older. All male dogs over six months of age must be neutered. Unspayed females will be taken on a case by case basis and will not be accepted if in heat. Should an unaltered female become pregnant while at Cheeky Dog LLC, we will not be held responsible for the pregnancy or puppies resulting from that pregnancy.

BEHAVIOR: All dogs must be non-aggressive and not food or toy protective. Owners will certify their dogs have not harmed or shown any aggressive or threatening behavior towards any person or any dog(s). Please remember: your pet will be spending time with other pets and the safety and health of all animals is our main concern. We reserve the right to refuse or to reject at any time, any dog who will be a safety hazard to the other dogs in our care or who we feel will not safely integrate with the rest of the dogs.

COLLARS AND LEASHES: While being walked, Cheeky Dog LLC will use, if deemed necessary for safety purposes, a Halti, a Gentle Leader head collar, or pinch collar.

VACCINATIONS: All dogs must have up-to-date vaccinations. Owners must submit written proof of Distemper, Rabies and Bordetella vaccinations (the city of New York requires Bordetella be given every six months). Puppies must have at least two rounds of "puppy shots".

FLEA PROTECTION: All dogs must be wearing flea protection (from April - November) in the form of a topical liquid such as Frontline or Advantage. Flea collars are not acceptable.

HEALTH: All dogs must be in good health. Owners will certify that their dogs are in good health and have not been ill with a communicable condition in the last 14 days. Upon admission, all dogs must be free from any condition which could potentially jeopardize other guests.

EMERGENCY CARE: Cheeky Dog LLC will try to contact you if your dog becomes sick or injured. If that is not possible and your dog needs immediate care, we will seek medical attention at a veterinary facility at your sole expense. We currently use Hope Veterinary Services located at 390 Atlantic Ave. Brooklyn, NY.

FOOD: If your dog will need to be fed while in our care, we will happily provide him with a private crate to have his meal with food that you provide from home.

MEDICATION: If your dog will be needing medication while in our care please provide us with the medication and instructions and we will make sure he gets it.

DAYS AND HOURS: Monday through Friday from 7:00 am to 8:00 pm. Saturday 10:00 - 5:00. Reservations are recommended. You must pick up your pet no later than the posted closing time. You will be charged 5.00 for every 15 minutes that you are late.

FEES: Fees are based on a pass plan: One, five, ten or twenty days are available. A pass is valid for six months from date of purchase. NYC sales taxes of 8.38% are not included in prices.

PAYMENT: Payment is required in full before your pet leaves our facility. We accept Visa, Mastercard, Discover, American Express and checks with identification and cash. We will keep your credit card on file and can apply charges as incurred or you may pay by another means.

BOARDING: Boarding rates are based on a 24 hour period. If the dog will stay beyond the 24 hour period, you will be charged additional daycare rates. Boarding requires a 25% deposit. Must give 24 hours cancellation notice or deposit is not refundable.

Drop off: Dogs may be dropped off any time between 7:00 am and 7:00 pm M-F, 10:00 am and 4:00 pm Sat.
No drop offs on Sunday.

Pick up: Dogs must be picked up by: 7:30 pm M-F, 4:30 Saturday, by appointment Sunday.

CANCELLATIONS: We request that if you need to cancel, you notify us by phone or email 24 hours in advance.
